#### **I. ACADEMIC RESEARCH:**

The Research Group CNPq Medicinal Chemistry - UFSJ offers free academic licenses for use in academic research in order to promote and support academic research in good faith. "Academic Research" means nonprofit research conducted at Licensee's premises that does not benefit a commercial entity and which is not subject to consulting or licensing obligations or other granting of rights to any business entity. The Research Group CNPq Medicinal Chemistry - UFSJ hopes that the research findings made under this Agreement will be released into the public domain. Other uses are subject to Section VII.

#### **II. DEADLINE:**

The term of this Agreement is one year from the Effective Date. Licensee may request an extension for an additional period of one year and may grant eligibility and may grant an extension in its sole discretion. Academic Licenses may be terminated at any time upon notice to Licensee, at the sole discretion of the CNPq Medicinal Chemistry Research Group - UFSJ, with or without cause and as described in Section XV (Termination).

#### **III. ELIGIBILITY:**

Eligibility for an Academic License will be determined for each Individual Research Group. Thus, eligibility may differ between distinct research groups within a single-degree grant institution, and Academic Licenses apply only to the research group of a particular Principal Investigator. The CNPq Medicinal Chemistry Research Group - UFSJ, in its sole discretion, will determine Licensee's eligibility for an Academic License, depending on the continued accuracy of the pertinent information provided by Licensee and the continued compliance with this Agreement. Eligibility for

an Academic License is not permanent and eligibility will be re-evaluated periodically. Any determination of academic eligibility and academic licensing policy of the Research Group CNPq Medicinal Chemistry - UFSJ may be changed at any time without prior notice, at the sole discretion of the Research Group CNPq Medicinal Chemistry - UFSJ.

#### SAW. GRANT OF LICENSE:

During the Term, and in accordance with the terms and conditions of this Agreement, the CNPq Medicinal Chemistry Research Group - UFSJ grants to Licensee a nonexclusive and non-transferable license to "Use" any software product ("Software") that The Research CNPq Medicinal Chemistry - UFSJ choose to make available and accompanying documentation In the form described below under "Scope of the License." "Use" means internal end-use by Licensee at his research facility for purely non-commercial academic research. This is a license agreement and not a sales contract. All rights not specifically granted are reserved to the Research Group CNPq Medicinal Chemistry - UFSJ. Licensee will use its reasonable efforts in good faith to notify Licensee's research group members of the existence of this Agreement and the Scope of License and other license restrictions.

#### VII. SCOPE OF LICENSE:

Licensee may download and install the Software and use the Software on computers at its research facilities. Licensee may not: disable or disregard any time limitation mechanism contained in the Software; Modify, translate, reverse engineer, decompile, disassemble or create derivative works based on the Software; Rent, lease, grant a security interest in or otherwise distribute or transfer rights to the Software; Or remove any proprietary notices or labels on the Software. Licensee may not permit anyone other than Licensee and immediate members of his or her research group to use the Software. Licensee shall not, and shall not permit its members of the research group to use the Software in any manner other than in accordance with the terms of this Agreement.

#### VIII. WHEN ACADEMIC BECOMES COMMERCIAL:

The reality of the modern world is that academic research is rarely non-commercial. The compounds are designed and licensed to leading pharmaceutical companies. Discoveries lead to university spin-offs. Collaborations with commercial entities blur the lines of public and private research. Software, sometimes competing with the offers of the Research Group CNPq Medicinal Chemistry - UFSJ, is written and distributed, licensed or patented. The Research Group CNPq Medicinal Chemistry - UFSJ apprecia this complexity and lists the behavior expected and required by the Licensee in any of the following situations:

**Contract Search.** Contractual research means that the Software is used for the express benefit of a business partner, including, but not limited to, virtual tracking, database preparation, or crystallographic refinement. The Research Group CNPq Medicinal Chemistry - UFSJ requires that both Licensee and the commercial partner have current (and actively maintained) licenses or acquire the appropriate licenses.

**Drug-design.** Research Group CNPq Medicinal Chemistry - UFSJ wants every academic group well in its efforts to improve the well being of humanity. If the Software is used in the discovery process for which a university, department, or research group eventually receives a revenue stream (including but not limited to license fees, royalties), the Research Group CNPq Medicinal Chemistry - UFSJrequer A commercial retroactive license to the Annual Package of the Research Group CNPq Medicinal Chemistry - UFSJPreçoções actual) are paid to the Research Group CNPq Medicinal Chemistry - UFSJ for each year for this period of discovery.

**Software development.** "Derivative Software" means software that incorporates or is built into

applications CNPq Research Group Medicinal Chemistry - UFS or tools kits for redistribution to other parties. The end users of the Derivative Software must request the appropriate licenses from the CNPq Medicinal Chemistry Research Group - UFSJ, in case such software is distributed for consideration, that Licensee must negotiate a fair royalty with the CNPq Medicinal Chemistry Research Group - UFSJ.

Generation of public database. Licensee must obtain an exemption from the CNPq Medicinal Chemistry Research Group - UFSJ to include information generated by the Software in a publicly accessible database. In general, we encourage the use of our tools to improve the quality of public data available.

Public websites. Licensee must obtain an exemption from the CNPq Medicinal Chemistry Research Group - UFSJ to create a publicly accessible website that includes data generated by the Software or that enables remote access to the Software. The appropriate allocation to the Research Group CNPq Medicinal Chemistry - UFSJ for the Software licenses used to create the site is necessary.

Comparative studies. CNPq Research Group Medicinal Chemistry - UFSJ requires the notification of any publication comparing our methods with those of others. We encourage communication about the purpose and conclusions of any work prior to publication. The Research Group CNPq Medicinal Chemistry - UFS reserves the right to restrict the duration of the licenses granted for this purpose.

Reverse engineering. The CNPq Medical Chemistry Research Group reserves the right to prohibit individuals, research groups and even institutions that acquire licenses for the purpose of producing software or comparable resources and to seek rewards for the appropriate judicial channels. Any and all information (including, without limitation, source code) discerned through reverse engineering or decompilation or disassembly is hereby assigned by the Licensee and the Institution to the Research Group CNPq Medicinal Chemistry - UFSJ. It is a confidential business secret of the Group Chemical Research – UFSJ.

#### IX. KEYS OF LICENSE:

Licensee acknowledges that the Software must be activated by time limited (and potentially limited by machine) license keys. The Licensee will receive his license key from the Research Group CNPq Medicinal Chemistry - UFSJ on an annual basis or as otherwise determined by the Research Group CNPq Medicinal Chemistry - UFSJ.

#### X. AUDIT:

The CNPq Medical Chemistry Research Group reserves the right to audit Licensee's compliance with this Agreement from time to time during normal business hours.

#### XI. NO WARRANTY:

THE SOFTWARE AND DOCUMENTATION ARE PROVIDED "AS IS" AND WITHOUT ANY WARRANTY OF ANY KIND. The Research Group CNPq Medicinal Chemistry - UFSJ ITS SUPPLIERS DISCLAIM ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. SOME JURISDICTIONS DO NOT ALLOW EXCLUSIONS OR DISCLAIMERS OF WARRANTIES, SO THE ABOVE EXCLUSIONS OR EXEMPTIONS MAY NOT APPLY.

#### XII. DO NOT SUPPORT:

No support is provided with an Academic License. The CNPq Medical Chemistry Research Group - UFSJ may, in its sole discretion and on its own schedule, but without any obligation, review the

merits of any reported problems, improvement requests or questions about the use and may provide a response.

### XIII. TITLE:

The title, ownership and intellectual property rights in the Software and Documentation will remain in the Research Group CNPq Medicinal Chemistry - UFSJ. The Software and Documentation are protected by copyright and other intellectual property laws and international treaties.

### XIV. NOT DISCLOSED:

Licensee shall take reasonable steps to maintain the confidentiality and business secrecy of the Software, Documentation and other proprietary information and materials of the Research Group CNPq Medicinal Chemistry - UFSJ provided to Licensee. Licensee's obligations under this Section shall survive the expiration or termination of this Agreement for a period of three (3) years.

### XV. TERMINAÇÃO:

Além dos direitos de rescisão do Grupo de Pesquisa CNPq Química Medicinal - UFSJ na Seção IV (Prazo), este Contrato será rescindido automaticamente e imediatamente se o Licenciado não cumprir com os termos e condições aqui descritos. Após a rescisão devido à comercialização, de acordo com a Seção "QUANDO ACADÊMICO SEJA COMERCIAL", o Licenciado deverá adquirir uma licença comercial apropriada e celebrar um contrato de licenciamento padrão. Após a expiração ou rescisão em quaisquer outras condições, o Licenciado irá destruir todas as cópias do Software e Documentação e dentro de trinta (30) dias enviar uma certificação escrita de conformidade com a Grupo de Pesquisa CNPq Química Medicinal - UFSJ.

### XVI. EXPORT CONTROLS:

The Software and related technology may not be downloaded or exported or re-exported to any country without the prior consent of Tx Biotechnology Enterprise. In addition, Licensee agrees to comply with any other applicable export control laws of Brazil and any local laws in its jurisdiction that may affect the right to import, export or use the Software. Licensee also represents and warrants that it will not use, or authorize, or authorize others to use the Software in connection with the design, development, production, storage or use of any chemical or biological weapons.

### XVII. LIMITATION OF LIABILITY:

To the maximum extent permitted by applicable law:

In no event shall the CNPq Chemicals Research Group or its suppliers or resellers be liable to Licensee or any other person for any indirect, special, incidental or consequential damages of any nature, including, without limitation, damages for lost profits or Revenue, business interruption, loss of data, computer failure or malfunction, or any and all other similar or foreseeable damages or losses.

Under no circumstance shall the CNPq Medicinal Chemistry Research Group - UFSJ be cumulatively liable for any direct, indirect, special, incidental or consequential damages of any kind in excess of one hundred dollars (US\$ 100), even if the CNPq Química Medicinal – UFSJ. You have been advised of the possibility of such damages, or for any claim by any third party.

Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, in which case the exclusion and limitation above may not apply.

Each party shall be responsible for all reasonable claims for damages to any property or persons arising solely from or as a consequence of the negligent act or omission of such party or its

students, subordinates, employees, agents or contractors, by the other party or by A third party; Provided that neither party is liable for damages resulting wholly or in part from any negligent act or omission of the other party or its students, subordinates, employees, agents or contractors.

#### XVIII. FINAL USERS:

The Software is provided with rights governed by Law No. 9,279 of May 14, 1996, Computer Program Law No. 9609/98 and Copyright Law No. 9.610 / 98.

#### XIX. CITATION AND ACKNOWLEDGMENTS

Users should quote the programs and enter their names in the key words of the scientific papers.

#### XX. GENERAL:

This Agreement represents the entire agreement on the subject matter hereof and may be amended or waived only by a deed executed by both the Licensee and the Research Group CNPq Medicinal Chemistry - UFSJ. If any provision of this Agreement is found to be unenforceable, such provision shall be amended only to the extent necessary to render it enforceable. The application of the United Nations Convention on Contracts for the International Sale of Goods is expressly excluded. Sections VII, VIII, X, XI, XII, XIII, XIV, XV, XVI, XVII, XVIII and XIX of this Agreement shall survive any termination or expiration of this Agreement. The Licensee acknowledges that the CNPq Medicinal Chemistry Research Group - UFSJ would create substantial damages if Licensee breached this Agreement and agreed that, if this happened, the Research Group CNPq Medicinal Chemistry - UFSJ has the right (in addition to any other rights or remedies) to obtain An injunction of any court with jurisdiction, without posting of bond or other security. Any legal question will be resolved only in the region of Divinópolis, Minas Gerais.
